RESOLUTION NO. 25-5

A VISION ZERO RESOLUTION PROCLAIMING THE CITY OF ARCHIE'S COMMITMENT TO IMPROVING TRAFFIC SAFETY BY ELIMINATING FATAL AND INJURY CRASHES AND THE ADOPTION AND IMPLEMENTATION OF THE 2025 SAFETY ACTION PLAN.

WHEREAS, the City of Archie recognizes that the safety and well-being of its residents, workers, and visitors are of the highest priority; and

WHEREAS, there have been no crashes resulting in fatalities but eight crashes resulting in injuries, including one involving a bicyclist, within the City between 2015 and 2024; and

WHEREAS, the number of injury crashes has increased in recent years; and

WHEREAS, the City recognizes the need for action to increase safety and prevent deaths and serious injuries within City Limits; and


WHEREAS, the 2025 Safety Action Plan provides a framework for improving safety using the Safe System Approach to create a future where every resident, especially children, can walk, bike, and drive safely in Archie, supported by infrastructure that meets the current and future needs of the community.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF ARCHIE, MISSOURI, AS FOLLOWS:

Section 1. The Board of Aldermen of the City of Archie, Missouri, hereby reaffirms and adopts the City of Archie's Vision Zero policy with the ultimate goal of achieving zero traffic crash-related fatalities and injuries by the year 2040.

Section 2. The Board of Aldermen of the City of Archie, Missouri, hereby adopts the 2025 Safety Action Plan with appendices.

Section 3. The Board of Aldermen of the City of Archie, Missouri, hereby formalizes the creation of a Traffic Safety Commission of three or more members appointed by the Mayor, and is responsible for overseeing the implementation of the 2025 Safety Action Plan.






